Directions: Willard is 8 miles west of Greenwood on County Hwy G.

Registration: \$30.00 individual, \$15.00 family (**3 or more**). 10:00 to 11:30 a.m. at the Willard Athletic Club. 12:00 noon start, for anything on human powered wheels. Helmets required for all racers. Online registration available at Midwest Events.

Course: 1---16 mile loop (road bikes, mountain bikes, tandems, and recumbents)
1---7 mile out and back (wheel chair, roller blades, and others)
Roads are lightly traveled blacktop, five corner loop for 16 miles, corners swept, monitored and the course will be sagged.

Perks: We'll think of something to give you. All riders that do all three LBR events will be entered into a \$100.00 raffle to be drawn at the GET THE LEAD OUT time trial. Must be present to win. Free pre-ride food and lunch after.

Awards: Awarded to fastest time male and female in the 16 mile time trial event. Middle of the pack award. Must be present to win.
1st—3rd place awards for each category (road bike, mountain bike, tandems, recumbent, wheel chairs, roller blades, and others). Road bikes/mt. bikes will be a combined category with 1st—3rd place awards given in the usual Wisport male and female age categories.
